Today, you were treated for an animal bite with multiple complex lacerations on your face and upper body. Essential hypertension was also noted during your visit.

Home Care Instructions

1. Clean the wound gently with soap and water twice daily to prevent infection.
2. Apply a sterile bandage (protective covering) to the wound, changing it daily or if wet.
3. Elevate the affected area to reduce swelling and promote healing.
4. Avoid scratching or picking at the wound to prevent scarring and infection.
5. Use a cold compress (ice pack wrapped in cloth) for 15 minutes to reduce swelling.
6. Monitor the wound for signs of infection, such as redness or pus, and report changes.
7. Keep the wound dry and avoid submerging it in water until fully healed.
8. Follow up with your healthcare provider if you notice any unusual symptoms.

Activity & Lifestyle Recommendations

- Limit physical activity to avoid stress on the wound; rest is crucial for healing.
- Avoid alcohol consumption to support optimal recovery and wound healing.
- Gradually resume normal activities as the wound heals and per your provider's advice.

Diet & Hydration

- Maintain a balanced diet rich in vitamins C and E to support tissue repair.
- Stay hydrated by drinking at least 8 glasses of water daily to aid recovery.
- Avoid excessive caffeine and alcohol, which can dehydrate and impede healing.

****Red-Flag Symptoms & When to Seek Help****

- Increased redness or swelling around the wound.
- Fever above 101°F or chills.
- Pus or foul-smelling discharge from the wound.
- Severe pain not relieved by rest or cold compress.
- Difficulty breathing or swallowing.

****Follow-Up Plan****

- Schedule a follow-up appointment with your primary care provider in 7-10 days.
- Consider a blood pressure check to monitor hypertension.
- Follow up on the abdominal CT scan as ordered by your provider.

Take all medicines as prescribed. If complications arise from medicines or symptoms or condition worsens, proceed to Emergency Department or return to clinic immediately.
